## NURSING INDUSTRY - CANADA



According to the Canadian Nurses Association (CNA), there is a current shortage of nurses in Canada estimated at more than 50,000 and this shortage is expected to increase to 139,700 by 2026.



The CNA also reports that the nursing workforce in Canada is aging, with nearly one-third of nurses aged 55 or older. As these nurses retire, the demand for nursing services will continue to grow.



In addition, the aging population in Canada will also increase the demand for healthcare services.

# BECOMING A NURSE IN CANADA (step-by-step process)

1. **Initial Assessment**  
Get your qualifications, experience and licensing assessed by National Nursing Assessment Service (NNAS).
2. **English Language Proficiency**  
You must prove your English proficiency by completing an approved proficiency test, such as IELTS or CELBAN.
3. **Registration with the College of Nurses of Ontario (CNO)**  
You must apply for nursing registration with CNO.
4. **Competency Assessment**  
A competency assessment is needed to ensure you have the knowledge, skills, and judgment required to practice safely and effectively. Depending on the assessment results, additional training may be required for registration.
5. **Registration Exam**  
You must successfully complete the registration examination approved by CNO for the type of nursing (RN or RPN) you want to practise
6. **Judisprudence Exam**  
The exam is designed to ensure that nurses understand their legal and ethical obligations and are able to apply this knowledge to their practice.

## 18-Month program

- CELBAN/IELTS Exam Preparation
- Registration & Jurisprudence Exam Preparation

## 12-Month program (Advanced)

The 12 month program is for IENs who already meet the English language requirements. This program includes all modules except for language training. Modules include:

- Nursing Professional Development (review)

## FREQUENTLY ASKED QUESTIONS

### **Can I work while studying with TEMC?**

Yes. TEMC is a Designated Learning Institution (DLI) under the International Student Program (ISP) approved by the Government of Canada. International students enrolled in our Canadian Nursing Review programs are eligible to work part-time up to 20 hours per week during studies, and up to 40 hours per week during academic breaks, without a work permit.

### **What happens if my visa gets refused?**

IENs have generally experienced a very high approval rate for visas for Nursing review programs. However, if your visa is rejected, we encourage all applicants to refer to the Refusal Letter to determine the reasons for the rejection, and then to try and resubmit. We have seen on many occasions, students successfully receiving their visa approval after their 2nd or 3rd resubmission.

### **Can I bring my partner / spouse / children with me?**

In the past, students have been able to bring their families. However, it should be noted that not all IENs are automatically eligible to do so. In some circumstances, it may be recommended for IENs to come to Canada on their own and bring their families permanently when the time is right. We recommend IENs to consult with a licensed immigration consultant.

### **Where is TEMC Located?**

TEMC's campus is located in North York, Ontario. A vibrant and diverse community suburb of Toronto with a wide range of cultural and recreational activities, as well as easy access to transportation, healthcare, and offers a high quality of life for its residents. ## **What is the National Nursing Assessment Services?**

The National Nursing Assessment Service (NNAS) provides a streamlined assessment service for IENs interested in applying to be a registered nurse in Canada. The purpose of the NNAS application process is to evaluate and authenticate your nursing qualifications, work experience and nursing licenses.

## **What is the CELBAN English Exam?**

CELBAN is known internationally as a unique nursing specific-purpose language exam, and is informed by nursing and language testing professionals. CELBAN reflects authentic nursing communication and evaluates English language proficiency in listening, writing, reading and speaking.

## **What is the NCLEX-RN exam?**

Registered Nurses (NCLEX-RN) is an entry-to-practice examination for those applying to become a Registered Nurse. It tests the competencies nurses need at the beginning of their careers. Anyone applying to practise as a Registered Nurse in Canada must pass the NCLEX-RN exam.

## **What happens if I fail the Registration exam?**

There is no limit to the number of times you can write the Registration until you pass. You can take the exam once in any 45-day period (up to a maximum of 8 times per year).

## **Can I take an IELTS exam instead of CLBAN Exam?**

YES. IENs can take the IELTS exam without needed to take the CLBAN exam. As of January 2023, both IELTS (general) and IELTS (academic) are both accepted English language exams. Please note the IELTS exam will only be accepted when written within two years prior to applying for registration
